May, 2021 (Washington, D.C.) -- ReVision's new work, *Passage*, celebrates the company's 10th year anniversary season. Artistic Director Shannon Quinn and ReVision dancers will present an outdoor, physically distant performance to celebrate 10 years of dance and community. With a cast of 6 dancers, this site-specific piece will walk audiences through 4 locations within the Brookland neighborhood surrounding Dance Place. The work will also feature an Augmented Reality component to reflect on the past decade of growth and change. The various artistic spaces of 8th Street will serve as the backdrop for this evening-length work as audiences witness ReVision's unique culmination of modern dance and community building.

This work is supported by The Carla Fund for Choreography and Performance, established by the Howard and Geraldine Polinger Family Foundation in 2017 to honor the career of Dance Place Founding Director Emerita Carla Perlo. The Fund is intended to support the creation of new dance works and residencies at Dance Place.
