## Dance Place Presents Wolver Maroon From Heart Stück Bernie

Choreographer Sarah Beth Oppenheim Announced as 2024-2025 Recipient of the Carla Perlo Fund for Choreography and Performance

**WASHINGTON, D.C.** (June 25, 2025): On July 11-13 2025, **Dance Place** will present *Wolver Maroon* from Heart Stück Bernie. Tickets can be purchased <a href="here">here</a>.

Choreographer **Sarah Beth Oppenheim** describes *Wolver Maroon* as a feminine howl at the blood moon. From stark solo moments to a raucous ensemble of 32, the work includes art direction from Ben Furgal, lighting from Ben Levine, as well as costumes by Claire Alrich and Faryn Kelly. It is Heart Stück Bernie's newest dance theater work that explores existential "whys" to "question, upend, carry, and hold us all accountable for day on the other side of night."

"I've been working on *Wolver Maroon* for the last two years to care for my dance community, practice Parent Artistry with grace, mess, and chaos for myself, my dancers, and their kids, and as an offering of the protective fangs, utter fears, and hardcore caretaking that comprise these times," said Oppenheim, Artistic Director of Heart Stück Bernie.

Reflecting Oppenheim's commitment to supporting parents, Parent Artist ticket discounts and family packs are offered for all performances. Free on-site childcare will be available with registration for the matinee performance on July 13, 2025.
